Sub: Approval to Shri Balasaheb Mane Shikshan Prasarak Mandal,
for establishment of a D. Pharmacy Institution at Ambap,
Hatkanangale, Kolhapur, Maharashtra.

Sir,

I am directed to state that on consideration of the
observations made by the Expert Committee which visited the
Institute on 27.11.90, the recommendations made by the Western
Regional Committee (WRC) at its Second Meeting held on 23.2.91,
and the re-assessment made by an Expert Committee of the WRC
held on 15.4.92, the All India Council for Technical
Education (AICTE) has accorded approval to the Balasaheb Mane
Shikshan Prasarak Mandal, Ambap, Hatkanangale, Kolhapur to
conduct a D. Pharmacy course during academic years 1992-93 and
1993-94 with an annual intake of 40 (Forty) subject to the
fulfilment of the following conditions:

- (1) The building where the classes for the above D. Pharmacy
course will be conducted is at present being used for
conducting B.Ed. courses. The Mandal shall ensure that the
B.Ed. classes are shifted to some other building and this
building is exclusively used for D. Pharmacy College.
- (2) At least 3 full-time teaching staff shall be recruited before
starting of the course.
- (3) No new course shall be started in the Pharmacy Institute
without the prior approval of the All India Council for
Technical Education (AICTE).
- (4) The intake of 40 shall not be altered without the prior
approval of the AICTE.
- (5) The Management including the Governing Council of the
Institute shall be constituted as per the AICTE guidelines
and also the Chairman shall be appointed as per the AICTE
guidelines (enclosed).
- (6) Admissions shall be made on merit as per the guidelines
issued by the AICTE and no capitation or donation of any
kind shall be charged for admissions.

The tuition and other fees shall be charged as prescribed by the State Government within the overall criteria prescribed by the AICTE from time to time.

The teaching staff shall be recruited on an All India basis by open selection, and as per procedure, qualifications, experience, etc. as prescribed by the AICTE from time to time. State-based selection would be permissible for such posts for which the State Government prescribes "State-based selection" as a general policy.

(9) The accounts of the Institute shall be audited by a Chartered Accountant and be open for inspection by the AICTE or anybody authorized by it.

(10) The Mandal and the Institute shall fully comply with the conditions listed in the two undertakings and submitted to the AICTE, and shall follow strictly any further conditions as may be laid down by the AICTE from time to time.

In the event of non-compliance by the Society or the Institute with the above conditions, the AICTE will be free to take measures for the closure of the programme and withdrawal of its approval without consideration of any related issues and that all liabilities due to closure would be that of the Society and/or the Institute.

An Expert Committee of the Western Regional Committee (WRC) will visit the Institute in April/May, 1994 to assess compliance with the above conditions. Further approval or otherwise of the Pharmacy Diploma Programme after the academic year 1993-94 will be considered by this Council based on the report of the Expert Committee as stated above.

You are requested to kindly take necessary action in the matter and keep the WRC, Bombay and this Office informed of the progress made in this behalf.

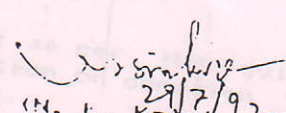

Model Constitution of the Governing Bodies/Committees etc. of
Private Technical Education Institutions and appointment of their
Chairmen

The Governing Body shall have atleast 11 members including the Chairman and the Member-Secretary. The Registered Society shall have 4 members including the Chairman and the Member-Secretary, and the remaining 5 members shall be nominated as indicated below:

1. Chairman : to be nominated by the Registered Society/ Trust etc.
- 2 to 5 Members:

Other Nominees from the Central Government/AICTE/State Government.

3. Nominee of the Central Government/Ministry/Department dealing with Technical Education-Regional Officer (Ex-Officio).
4. An industrialist/technologist/educationist from the Region to be nominated by the concerned Regional Committee as nominee of the AICTE.
5. Nominee of the Affiliating Body, University/State Board of Technical Education.
6. Nominee of the State Government-Director of Technical Education (Ex-Officio).
7. An industrialist/technologist/educationist from the Region nominated by the State Government.
8. Principal Director/Dean of the institution (as nominee of the Society/Trust, etc.) - Member-Secretary.

The number of members can be increased equally by adding nominees of the registered society and by adding an equal number of AICTE nominees who shall be industrialists/technologists/educationists from the region keeping in view the interest of the Technical Institution and are to be nominated by the Regional Committee. The total number of members of a Governing Body shall, however, not exceed 21.

The Chairman of the Governing Body should preferably be a technical person either an entrepreneur, or an industrialist or an educationist of repute who is interested in the development of technical education, is a member of the parent Society/Trust and has demonstrated an interest in promotion of quality education in general and, technical education in particular.
